NOTE: This product is designed to clean professional spray guns and may not be compatible with all surfaces. Test first in an inconspicuous area to ensure compatibility. **Always wear eye and face protection in case material splashes back toward you during cleaning operations.**



Hold in upright position and point arrow on button away from you. Position spray gun over a paint waste barrel to collect waste material. To clean outside of gun, hold 6 to 10 inches from surface and apply. Wipe dry with a clean cloth. To clean inside the gun, use the extension tube. Depress trigger to allow waste to drain and spray directly into gun's cup adapter. Continue spraying until waste draining out is clear. Turn gun over and spray directly into fluid tip and air passages while depressing trigger. Remove air cap and clean inside in a similar fashion. Wipe dry with a clean cloth and replace air cap.
